**Service Fee;**

The service fee payable is **\$1650 incl GST.**

The booking fee is \$220 including GST is payable on return of the Contract. This Booking Fee is non-refundable and is deducted from the service fee and is valid for one breeding season only. No mare will be bred until the booking fee is received. The Residual Service Fee \$1430 including GST is payable on 21 days Positive Pregnancy Test. The Service Fee is only fully refundable if the mare fails to have a positive pregnancy at 21 days. All fees include GST.

**Free Return;**

The mare is entitled to a free return to Erin Spin Rey if the foal dies within forty eight hours of foaling or if the foal is still born, in both cases a report certified by a practicing Veterinary Surgeon is required. The Free Return is only applicable to the year immediately following the service of Erin Spin Rey. It is also a pre-condition to the obtaining of a free return in the following breeding season that payment of the original Service Fee is made in accordance with the Service Fee paragraph, time being of the essence, otherwise the potential right to a free return is null or void.

**Conditions**

*The Owner of the mare warrants that the above details of the mare are true and correct. The mare owner also warrants that the mare is healthy and in suitable breeding condition. If Erin Spin Rey becomes unavailable to breed for some reason before serving or if the mare in the contract dies then this contract will be void. The service fee and usage fee will be returned to the mare owner. The Mare Owner agrees to pay all charges applicable to the broodmare and progeny. This contract is void if the mare is sold after the date on this contract.*
